How do imports work in Timor-Leste?

Imports: When commercial goods enter Timor-Leste, they do so by air or by sea, or via a land border. When the goods arrive, they are initially considered to be in "temporary storage." After arrival, there is a legal requirement for the goods to be placed under a "customs treatment" within a specified time frame.

What does the customs authority do in Timor-Leste?

The Customs Authority helps the Government of Timor-Leste to control the movement of goods, vehicles, ships, and aircraft that enter and leave the country. As well as protecting our borders from the import or export of illegal or restricted goods, we also help to collect duties and taxes which is an important source of national revenue.

What is a customs declaration in Timor-Leste?

The customs declaration, which is known in Timor-Leste as the Declaração Aduaneira Única (DAU), is processed electronically using the ASYCUDA World system. This document allows us to determine what duties and taxes may be due, and to confirm the presence of any required permits or licenses required for other government agencies.

How is tax calculated in Timor-Leste?

If you import goods commercially into Timor-Leste, you must pay the duties and taxes that are applicable by law. There are three types of duty or tax on imports, as follows: Import Duty, which is also commonly known as "customs duty", is calculated at a rate of 5% of the value of the goods. In other words, the base value for Sales Tax = A+B+C

What is excise tax in East Timor?

Excise taxes are imposed on the import or domestic production (but not both) of certain goods. Goods are exempt from excise taxes if they are exported from East Timor within 28 days of production and are exempt from import duty, or if they relate to the Timor Gap Agreement.

How to ship to Timor-Leste?

Determine the Harmonized System (HS) code for tariff and regulation details. Gather necessary export documents: commercial invoice, packing list, certificate of origin, and bill of lading. Verify any tariffs and ensure compliance with non-tariff measures. Choose a logistics provider experienced in shipping to Timor-Leste.

Nationals of East Timor can travel to 62 countries without visa, 24 countries with visa on arrival and 23 countries with e-visa. Passport of East Timor is restrictive with a Passport Power Index of 41.
