What is the procedure for providing information to Pakistan Customs computerized system?

A company's authorized person shall furnish all relevant information online to Pakistan Customs Computerized System using a specific user ID and password obtained under section 155D of the Customs Act, 1969.

How to get customs clearance for imported goods?

A copy of the Sales Tax Registration Certificate as an importer. A copy of the National Tax Number. Once the cargo vessel reaches the destination port and offloads cargo then custom clearance for imported goods started customs clearing agent checks whether an IGM (import general manifest) file in FBR's website or not.

How does customs clearance work?

(Out of Order Charge) The customs clearance process begins with the entry of a cargo vessel, plane or another transporter of merchandise in the country on the assigned ocean, land and airplane terminals. Once the goods have reached the customs port, the port authorities issue the Import General Manifest (IGM) to every shipment.
