What is customs duty on solar panels?

According to TARIC, customs duty for photosensitive semiconductor devices, including photovoltaic cells whether or not assembled in modules or made up into panels; light-emitting diodes, code 8541409000, is 0%. In the HTS tariff system, the duty for solar cells assembled into modules or made up into panels (code 8541.40.60.15) is also 0%.

Are re-imported solar cells exempt from import regulations?

KLC further explained that domestically produced solar cells or modules that are re-imported are exempt from the aforementioned import regulations. Customs is entitled to exercise their authority to inspect such goods to confirm that the origin of the imported goods is indeed Taiwan.

How to import photovoltaic panels?

Can I import solar cells from Cambodia?

Imports of solar cells and modules from Cambodia, Malaysia, Thailand, and Vietnam will not be subject to suspension of liquidation or cash deposit requirements if accompanied by a certification attesting that they are not circumventing the ADD/CVD orders. There are three types of certifications:
