Personal effects MAY be cleared in the absence of the owner but it is preferable for the owner to be in South Africa prior to the arrival as SA Customs may ask for the owner of the consignment's passport to be

be submitted to Customs at the time of clearance of all vehicles imported into South Africa. A "Letter of Authority" (LOA) issued by the National Regulator for Compulsory Regulation in Pretoria - South Africa has to be submitted to Customs at the time of clearance of all motor vehicles (excluding motor cycles) imported into South Africa.
