How does the export procedure work in Jordan?

In the case of foreign trade fairs, tariffs and duties will be paid only on the items sold abroad, based on counting of items returned to Jordan as compared to the packing list. The Export procedure is provided chronology from the time of goods leave the exporter Warehouse till it is loaded on the carrier.

Where can I find technical standards in Jordan?

Technical standards in Jordan, also known as the Jordan Quality Mark, are published in the Jordan Official Gazette in hard copy only and are registered in the Jordan Quality Mark database. The English version of the Jordan Official Gazette and a disk with the Jordan Quality Mark database can be purchased from JSMO.

What certifications does Jordan require for importing food products?

Jordan requires certain certificates for importing a number of food products, a detailed list can be found in Table 6 below. Fitness for Human Consumption Certificate. (FHCC) Product Validity for Consumption in the Country of Origin. (PVCCOOC) Approved flavor and/or coloring material.
